

ELECTION CANDIDATE QUALIFICATION AFFIDAVIT

I, _____, hereby attest and certify that I am a Qualified Voter, as defined in Article III, Section 2 of the Constitution of the Manchester Band of Pomo Indians, and that:

a) I meet the following requirements for eligibility to run for office as set forth in Community Council Resolution No. 03033622:

- (1) I am at least 25 years of age if running for the office of Chair, Vice-Chair, Secretary, or Treasurer, and at least 18 years of age if running for a Member-at-Large position, if such position has been authorized in accordance with the Constitution and Bylaws;
- (2) I possess a minimum of a high school diploma or GED;
- (3) I possess a valid California Class C Driver's License;
- (4) I am not employed in any capacity with the Manchester Band of Pomo Indians government, with any Tribal economic enterprise or entity, or as a contractor or employee of a contractor with the Tribe, or in any employment or financial position that would cause my election to office to create a possible conflict of interest;
- (5) I have not previously been removed from any elected position by the Community Council, and/or am not prohibited from holding office in the future;
- (6) I am not currently enrolled nor have been enrolled as a member of any other tribe;
- (7) I have not been found by the Community Council, acting in a quasi-judicial or deliberative capacity, to have committed any act constituting a crime under state law against the Tribe that would make me ineligible to hold office;
- (8) I have not been terminated for cause after due process, or resigned in lieu of termination, from employment from any government, private sector, or Tribal entity within the past ten (10) years;
- (9) I am not the subject or any current civil or criminal investigation by a government, private sector, or Tribal entity;
- (10) I have not suffered a misdemeanor or felony conviction in any court of competent jurisdiction such as a Tribal, state, or federal court of law; and
- (11) I am a currently a full-time resident in the state of California.

b) I am not automatically disqualified from running or holding office pursuant to Community Council Resolution No. 03033622 due to having been arrested for any serious crime involving violence against any person or person(s), with the use of a firearm, knife, or other deadly weapon, or any domestic violence incident, or incident of child abuse, and such charges were later dropped.

I declare under penalty of perjury under any applicable laws that the foregoing is true and correct. By signing this affidavit, I hereby acknowledge and expressly consent to submitting to a background check and agree to provide any relevant documentation to verify the facts that I have asserted herein.
